In announcing Ms. Bowers' appointment, Dean Sharon Nickols said, "The momentum we have achieved in building private support for the College will be maintained under Katrina's leadership. She is a dedicated professional whose experience is well suited to the responsibilities of the position."

Highlights on Recent Gifts

Glenn and Helen Burton Feeding the Hungry Scholarship Fund Established

Dr. Glenn Burton and members of his family, including daughter Betsy Burton Fowler (BSHE, '58), have established an endowed scholarship fund to support continuing development of research in human nutrition and new food crops. The fund is known as the Glenn and Helen Burton Feeding the Hungry Scholarship Fund. The fund will provide two scholarships annually to Ph.D. students, one in the Department of Foods and Nutrition and one in the Department of Crop Sciences.

Dr. Glenn Burton is an Alumni Foundation Distinguished Professor in agricultural and environmental sciences and a research geneticist who has developed and released more than 40 new varieties of grains, forage grasses, and turf grasses during his career at the Coastal Plain Experiment Station in Tifton. Mrs. Helen Burton, who died in August 1995, was a registered dietitian, who organized and coordinated the Meals on Wheels program in Tifton, as well as teaching nutrition to pregnant women through the Tift County Health Department.

In recognizing the Burton family at a luncheon announcing the scholarship, Dean Sharon Nickols stated, "Through their lifelong partnership, Dr. Glenn Burton and his wife, Helen, made the world a better place. We can read the headlines and realize how important it will be to continue their work to feed the world's hungry." Suzanne Elbon (M.S., Foods and Nutrition, 1995), a Foods and Nutrition doctoral student, is the first recipient of the Burton Scholarship.

Evelyn R. Harris Fund Created



Mrs. Evelyn Redfern Harris (B.S.H.E., 1938) believes in helping others, especially young people. She has created an Academic Support Fund to support activities to benefit an undergraduate or graduate

student each year. Students who receive the Evelyn R. Harris Award will use the funding to attend professional meetings, participate in workshops or seminars, or other professional development activities.

After earning her first degree from Georgia State College for Women in Milledgeville in 1930 and teaching in elementary school, Mrs. Harris became interested in Home Economics. She earned the B.S.H.E. from the University of Georgia in 1938.

Her dedication to educating others to make wise consumer choices and to develop their talents has been evident in her career as a County Agent in Barrow County and twenty years with the Jackson Electric Membership Corporation; as well as through 24 years of active "retirement." At 89 years young, Mrs. Harris maintains an exercise program, teaches Sunday School, participates in the DAR, and promotes the Winder Heritage Centennial Cookbook which she compiled in 1993. Until recently, Mrs. Harris wrote a column "Home Sweet Home" for the Barrow County Eagle newspaper. Mrs. Harris's leadership as a professional and community citizen was recognized by the Barrow County Chamber of Commerce "Meritorious Service Award" in 1989.


Listening to Mrs. Harris reminisce about her career is a history lesson in the modernization of rural households. As a County Agent, Mrs. Harris fostered women's leadership development through income generating activities and civic projects. As Home Economist for the Jackson EMC, she introduced many families to electricity and electrical appliances and the concept of a consumer-owned cooperative. Describing both her career and community service, Mrs. Harris states, "I've got a burning desire to improve things. To get more beauty around us and a better standard of living are worth working for." Mrs. Harris describes herself as " a do-er." The College describes Mrs. Harris as "a do-er who makes a difference."

Mrs. Harris credits her mother as a guiding influence in her life, and for instilling a need for education and moral character as her core values. Dean Sharon Nickols states, "Lifelong learning and lifelong service are keystones of Mrs. Harris's character. She exudes energy. The College is fortunate indeed to have an alumna with such dedication to others. Her legacy will endure through the Evelyn R. Harris Academic Support Fund."

Evelyn Harris was married to E.V. Harris in 1943. Mr. Harris died in 1965. Her son Ernest graduated from the University of Georgia Law School in 1972.

When the Annual Fund Calls..Don't Forget to Designate

Elizabeth T. Sheerer Graduate Scholarship Fund Will Benefit Child and Family Development

The College is proud to announce the establishment of the Dr. Elizabeth T. (Betty) Sheerer Graduate Scholarship Fund. The scholarship honors Dr. Sheerer's service as head of the CFD department. During the 27 years that she served as head, CFD provided national leadership in pioneering programs to train Head Start teachers, conducted model programs in early childhood development through the McPhaul Center, and initiated the first Ph.D. program in the College. Even though Dr. Sheerer retired, she remains active in the community by contributing her expertise in the area of mental health and personal and family well-being.

The goal is to endow the Elizabeth T. Sheerer Graduate Scholarship Fund at the \$25,000 level in the near future. Dr. Sheerer has contributed generously to launching the fund. Information about the fund was mailed to all CFD alumni who received their M.S. or Ph.D. degrees in Child and Family Development, requesting that they honor Dr. Sheerer's career with a contribution to the scholarship fund. Drs. Lynda and James Walters say they were delighted to sent their gift because "Betty's contributions to the College were fabulous and the department would not enjoy the stature it has in our field today were it not for Betty."

After serving as an Assistant Professor and Director of the Nursery School at UGA from 1952 to 1956, Ms. Brooke was employed in Iowa, Wisconsin, Maryland, and Pennsylvania. She returned to UGA in 1963 and retired in 1984, for a total of 25 years of outstanding leadership at the McPhaul Center and in the CFD Department. Ms. Brooke was a pioneer in programs to prevent child abuse, Head Start teacher training, curriculum for young children, and program evaluation of community day care centers.

Deferred Giving to the College of Family and Consumer Sciences: Insuring the Future Today

Deferred financial gifts to the College of Family and Consumer Sciences leave a legacy to benefit students and faculty. With a deferred gift, you give today, but the College will benefit some years later. Gifts may vary in size from small bequests to million dollar trusts.

There are two kinds of Deferred Gifts: (1) Life income gifts and (2) Estate gifts. Life income gifts provide either an income or the use of some asset for the duration of your life. Estate gifts are normally provided for in your Will or in the final distribution of your estate.

Life Income Gifts

Life income gifts can be created with cash, securities, and/or real estate. The asset is given to the University of Georgia Foundation to benefit the College of Family and Consumer Sciences, but you retain the right to receive income from those assets for as long as you live. At your death or the death of the last remaining beneficiary, the University of Georgia Foundation receives the remaining principal. Life income gifts may be pooled income funds or charitable remainder trusts.

<u>Pooled Income Funds</u> - Pooled income funds allow you to give away assets, such as stocks or bank savings, while keeping the right to receive the interest and/or dividend income. The University may use the remaining principal only after your death and the death of one surviving beneficiary if one is designated. Typical gifts range from \$10,000 to \$250,000. Advantages of a pooled income fund gift are:

1. You retain income for life often earning about double the quarterly income you were receiving.

2. You avoid capital gains taxes on the sale of appreciated securities.

3. You remove all or most of the assets donated from your estate, thereby reducing potential estate taxes.

4. You receive an income tax deduction based upon your age.

<u>Charitable Remainder Trusts</u> - There are a variety of charitable trusts which can be created, usually with assets worth \$250,000 or more. The charitable remainder trust provides lifetime benefits to you, the donor, and then to the College. You also have the benefits of tax deductions or reductions listed above.

Estate Gifts

Estate gifts may be made through a bequest in your Will, through a testamentary trust created by provisions in your Will, a life insurance policy, or a retirement plan.

<u>Bequests (Gifts by Will)</u> - A bequest is a gift made through provisions specified in your will. There are three types of bequests that can be made - a specific, residual, or contingent bequest.

<u>A specific bequest</u> - You leave a specific amount of money, a specific asset, or a specific percentage of your estate to the University of Georgia Foundation for the benefit of the College of Family & Consumer Sciences.

<u>A residual bequest</u> - Your bequest goes to the University of Georgia Foundation for the benefit of the College of Family and Consumer Sciences only after all debts, expenses, taxes, and other bequests have been paid.

<u>A contingent bequest</u> - A contingency bequest takes effect if the primary beneficiary dies or otherwise loses rights as a beneficiary. Example: If my child should predecease me then I leave my estate to the University of Georgia Foundation for the benefit of the College of Family and Consumer Sciences.

<u>Testamentary Trusts</u> - Your Will may direct that a portion of your estate will go to a pooled income fund or a charitable remainder trust. The pooled income fund or charitable remainder trust will then pay life income to a named beneficiary. After the beneficiary's death, the UGA Foundation will receive any remaining funds for the benefit of the College.

<u>Paid-up Life Insurance Policy</u> - You can donate a paid-up life insurance policy that you currently own. It is important to designate the University of Georgia Foundation as the owner and beneficiary of the life insurance policy with the proceeds benefiting the College of Family and Consumer Sciences.

How Do I Make a Gift?

As you consider your options, please let us know if you have questions. We would be happy to talk with you about how you can best achieve your charitable objectives through a gift to the College. We may be able to suggest ideas that meet your needs and the needs of the College. The UGA Foundation has Planned Giving Staff available to review draft bequest language with your attorney. Mistakes in language can be costly to the College and make it difficult to fulfill your wishes. Also, the University periodically offers deferred giving seminars at various locations throughout the country. A tentative schedule of upcoming seminars is presented on page 14 of this newsletter. If you include us in your will, please tell us. We would like to thank you and recognize you as a member of the Heritage Society. We will keep the information you share with us confidential. If you prefer your gift to remain anonymous, we will honor your request.
